(1) 準買家應參閱發展項目期數的售樓說明書，以了解該發展項目期數的資料。
Prospective purchasers are advised to refer to the sales brochure of the Phase of the Development for information on the Phase of the Development.

(2) 根據《一手住宅物業銷售條例》第 52(1) 條及第 53(2) 及 (3) 條：－
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance: -

第 52(1) 條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的 5% 的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第 53(2) 條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第 53(3) 條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則 – (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase- (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

A preliminary deposit of 5% of the Purchase Price shall be paid upon signing of the preliminary agreement for sale and purchase.

Balance of 95% of the Purchase Price shall be paid within 120 days after the date of the preliminary agreement for sale and purchase.

120-day Standby Mortgage Loan Payment Plan: (1% discount from the Price)

1. 樓價 5% 作為臨時訂金於簽署臨時買賣合約時支付。

A preliminary deposit of 5% of the Purchase Price shall be paid upon signing of the preliminary agreement for sale and purchase.

2. 樓價 95% 作為樓價餘款於簽署臨時買賣合約的日期後的 120 天內支付。

Balance of 95% of the Purchase Price shall be paid within 120 days after the date of the preliminary agreement for sale and purchase.

Purchasers selecting this Payment Plan (B) may make application for the “IN ONE” 80% Standby Mortgage Loan as stated in paragraph (4)(iii)(a) below.

(C) **「瑜」你所願 360 天現金優惠付款計劃: (照售價減 2%)**

360-day Cash Payment Plan: (2% discount from the Price)

1. 樓價 5% 作為臨時訂金於簽署臨時買賣合約時支付。

A preliminary deposit of 5% of the Purchase Price shall be paid upon signing of the preliminary agreement for sale and purchase.

2. 樓價 5% 作為加付訂金於簽署臨時買賣合約的日期後的 120 天內支付。

A further deposit of 5% of the Purchase Price shall be paid within 120 days after the date of the preliminary agreement for sale and purchase.

3. 樓價 90% 作為樓價餘款於簽署臨時買賣合約的日期後的 360 天內支付。

Balance of 90% of the Purchase Price shall be paid within 360 days after the date of the preliminary agreement for sale and purchase.

If the Purchaser, after the signing of the preliminary agreement for sale and purchase, wishes to change the Payment Plan or change any relevant discount(s), gift(s), financial advantage(s) or benefit(s) which require(s) update(s) to the entry(ies) on the Register of Transactions, the Purchasers can apply in writing to the Person so Engaged for such change not earlier than 30 days after the date of the agreement for sale and purchase but not later than 30 days before (whichever is earlier) the due date for payment of the balance of Purchase Price under the old and new payment plans, or (if applicable) the estimated material date for the Phase of the Development as specified in the agreement for sale and purchase. Whether the application is approved or not is subject to the final decision of the Person so Engaged. The application is subject to the following conditions: -

“IN ONE” 80% Standby Mortgage Loan (Applicable to Payment Plan (B) under sub-paragraph (4)(i))

買方可向如此聘用的人指定的貸款公司(「貸款人」)申請第一物業按揭貸款(「物業按揭貸款」)，物業按揭貸款申請必須在不遲於預期的貸款日前的 30 天由買方向貸款人以指定表格作出，並須由貸款人批核。物業按揭貸款受下列主要條款及條件限制:-

In case of any dispute, the decision of the Person so Engaged shall be final. However, this "Extended Defect Maintenance Offer" is personal to the Purchaser and is to be enjoyed by the Purchaser only. This "Extended Defect Maintenance Offer" is non-assignable, non-transferable and subject to other terms and conditions. The Owner and the Vendor's agent do not, and will not, involve in this "Extended Defect Maintenance Offer". The Purchaser shall have no claim whatsoever against the Owner and/or the Vendor's agent in relation to this "Extended Defect Maintenance Offer".

Option to purchase a Residential Car Parking Space
