In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential property(ies) to any person interested in purchasing by any method (including balloting).

Please note that the completion of the verification of a registrant's identity, any order of priority in respect of the selection of specified residential properties according to the result of the balloting, or the Vendor's admittance of any person to the waiting queue does not guarantee that that registrant/person will be able to purchase any specified residential property.
