All specified residential properties will be available for selection and purchase on a first come first served basis to any person interested in purchasing the specified residential properties.

A person interested in purchasing the specified residential properties shall submit the following to the Vendor at the Sales Office (i.e. From now till 31 July 2024 : 1/F, The Uptown, No.8 Maidstone Road, Tokwawan, Kowloon.
