第 52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的 5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第 53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的 5 個工作日內，就有關指明住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the specified residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

(a) 上海商業銀行住宅按揭服務 Residential Mortgage Services of Shanghai Commercial Bank

The Vendor and the Bank do not make any express or implied offer, representation, undertaking or warranty in relation to the application results and terms and conditions of the mortgage loan. Even if a purchaser fails to obtain any mortgage loan, he/she is still required to settle the Transaction Price and complete the transaction in accordance with the terms and conditions of the ASP.
