(a) The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to change the closing date and/or time of the tender and/or the place where the sale will take place in respect of all or any of the specified residential properties from time to time by amending and/or issuing the Sales Arrangements.

(b) Notwithstanding anything herein provided, if Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal or “Extreme Condition” is in effect in Hong Kong at any time from 10:00 a.m. to 11:00 a.m. on the day on which the closing time of the tender falls, the closing time of the tender will automatically be postponed to 11:00 a.m. on the next succeeding day in respect of which no Typhoon Signal No.8 or above is hoisted or Black Rainstorm Warning or “Extreme Condition” is in effect in Hong Kong at any time from 10:00 a.m. to 11:00 a.m.. For safety and maintenance of order at the Designated Venue, the Vendor reserves its absolute right to, in the case where the Vendor considers that there being any event or circumstance affecting or which may affect the safety, order or public health in the Designated Venue and/or its vicinity, postpone, extend or modify the date, time, period, place of sale or selection of specified residential properties or other procedures to such other date, time, period or place as the Vendor may consider appropriate. Details will be announced on the website of the Development and persons interested in purchasing the specified residential properties will not be separately notified of the same. The Vendor reserves the right to reject the entry of any person into the Designated Venue. The Vendor's decision in this regard shall be final and binding on all persons.
